Subject: Issue of a No-Objection Certificate for establishment of a Teacher Training Institution.

Preamble:

Orders were issued as contained in the Government Order dated 17-7-2003 read at (1) above, lifting the ban on issue of No Objection Certificates (NOCs) for establishment of TTIs offering Diploma in. Education (D.Ed.) and C.P.Ed. courses subject to the conditions stipulated therein. [C.P.Ed. course is now called Diploma in Physical Education (D.P.Ed.) Coursel. In accordance with the said Government Order dated 17-07-2003, the Director (R&T), Department of State Education Research and Training, Bangalore invited applications. The last date for receiving applications was 20-08-2003. After having received the applications the said Director submitted to Government a list of all the applicant-institutions along with the details relating to them. It contained the details of fresh applicant-institutions as also those of the applicant-institutions, which had applied in accordance with the earlier Government Order No. ED 110 PTI 2001, dated 27-07-2001 but had not been issued NOCs thereunder, as the Government Order dated 17-07-2003, read at (1) above, provided for considering the latter category of applications as new applications made thereunder. After having examined the said list, Government issued NOCs to the applicantinstitutions. This process was completed.

2. Government has, now, issued orders as contained in the Government Order dated 16-07-2005, read at (2) above, prescribing detailed procedure relating to the issue of NOCs for starting teacher training institutions offering D.Ed., and D.P.Ed courses every year. District Insulations of Education and Training in the State invited applications from private educational institutions seeking sanction of NOCs for establishing the teacher training institutions referred to above. The last date for receiving applications was 25-08-2005, which was extended to 20-09-2005. After the applications were received, the

Grincipal College Saudagar D.Ed. College GULBARGA epplicant-institutions were inspected by the inspection teams constituted for the purpose. Thereafter, the Principals of the District Institutes of Education and Training forwarded their recommendations to the said Director. The latter examined the proposals received from the said Principals and submitted to Government a list of all the applicant-institutions along with the details relating to them.

3. After having considered the proposals received from the said Director, Government hereby orders as follows:

- 4. Government are pleased to hereby issue No-Objection Certificate to Soudagar Education Society, Gulbarga for establishing a Teacher Training Institution offering D.Ed. course with Marati as the medium of instruction, with an intake of 50 (fifty only) at Ring Road, Gulbarga District subject to the following conditions:-
 - (1) No grant-in-aid shall be sought from Government;
 - (2) The institution shall provide adequate infrastructure, staff etc., as per the norms and standards prescribed by the National Council for Teacher Education;
 - (3) The institution shall give an undertaking to the effect that it shall abide by the State Government's orders/rules relating to admission of students and recruitment of staff to the institution issued from time to time, failing which the NOC granted shall be withdrawn;
 - (4) Statement of annual returns and list of members of the committee/Governing Council of the management as duly accepted/approved by the District Registrar shall be submitted every year to the Principal of the DIET concerned along with a list of the candidates admitted in the management quota for approval of the Principal of the DIET concerned;
 - (5) Any change in the management shall be permissible with prior approval of Government before the commencement of each academic year, failing which the management shall attract penal action in accordance with law;

- (6) The institution shall collect 'Tuition fee' and 'Other fee' as regulated by the Government from time to time. The amount so levied or collected shall be exclusively utilised by the Institution in accordance with rules;
- (7) No shifting of the institution shall be allowed except with prior approval of Government;
- (8) Closure of the institution shall be permissible only after obtaining prior approval of the Government;
- (9) The management should start the institution only after obtaining recognition from the National Council for Teacher Education.

ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Saudagar Education Society Hagarga Cross, Ring Road, Gulbaga, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Soudagar D.Ed College, Hagaraga Cross Ring Road, Gulbarga District, Karnataka for D.Ed Course of two year duration.

AND WHEREAS the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition to the institution for offering D.Ed course with an intake of 50 students order dated 09.07.2007.

AND WHEREAS a letter No.ED 122 PTI 2008 (B) dated 18.06.2009 has been received from the Principal Secretary, Primary and Higher Education, Education Department, Government of Karnataka and has recommended SRC to withdraw the recognition granted to D.Ed college, as the institution is not maintaining Norms and Standards as prescribed by NCTE.

AND WHEREAS the matter was placed before SRC in its 178th meeting of SRC held on 13-14 July 2009. The SRC considered the recommendation of the State Government of Karnataka regarding withdrawal of recognition to your D.Ed college and decided to issue Showcause Notice. Accordingly, Notice was issued to the institution on 12.08.2009. The institution submitted its written representation on 09.09.2009. The written representation was placed before SRC in its 183rd, meeting held on 22nd September 2009 and decided to issue Notice. Accordingly, Notice was issued to the institution on 04.11.2009.

AND WHEREAS as the institution has not submitted any written representation to the notice, the matter was placed before SRC in its 189th meeting held on 25-26 February 2010. SRC considered the matter and decided to issue Final Notice under section 17 for the following reasons:-

 Land documents of the new building/location for having own land in the Name of the institution/Society/Trust.

2. Building plan of the new building duly approved by the Government authority.

3. Building Completion Certificate from the Government authorities in the prescribed format.

- 4. Land Usage Certificate from concerned Government authorities stating that the land is exclusively permitted / sanctioned for Educational purposes only should be submitted.
- 5. Encumbrance Certificate from the Competent Government should be submitted.
- 6 Fixed Deposit Receipt of Rs. 5 lakhs towards Endowment Fund and Rs. 3 lakhs towards Reserve Fund kept in Joint Account for a period of 5 years in original should be submitted.
- 7. Certificate of Registration/Bye-law of the Society/Trust should be submitted.
- 8. The affidavit in Rs.100/- stamp paper in the prescribed format with Notary attestation should be submitted.
- 9. The institution has to submit filled in Questionnaire under section 17 (copy enclosed).

Accordingly, a Final Notice was issued to the institution on 13.04.2010. The institution has not submitted any written representation.

The Committee noted that the institution has not replied to the Final Notice dated 13.4.2010 and it was decided to withdraw recognition for the following deficiencies:-

 Land documents of the new building/location for having own land in the Name of the institution/Society/Trust is not submitted.

 Building plan, Building Completion Certificate, Land Usage Certificate and Encumberance Certificate of the new building duly approved by the Government authority have not been submitted.

• Fixed Deposit Receipt of Rs. 5 lakhs towards Endowment Fund and Rs. 3 lakhs towards Reserve Fund kept in Joint Account for a period of 5 years in original have not been submitted.

• Certificate of Registration/Bye-law of the Society/Trust are not submitted.

• The affidavit in Rs.100/- stamp paper in the prescribed format with Notary attestation is not submitted.

Under the above grounds, the Committee decides to withdraw the recognition for D.Ed. course w.e.f. 2011-12, as a special case in order to enable the ongoing batch of students in D.Ed. course, if any, to complete their final year course. But, it is made clear that the institution is debarred from making any further admission subsequent to the date of issue of this order.

NOW THEREFORE, it is hereby ordered that recognition accorded to Soudagar D.Ed College, Hagaraga Cross Ring Road, Gulbarga District, Karnataka to D.Ed course is withdrawn.

As per Section 18 of NCTE Act, 1993, there is provision to prefer an appeal against the above order of withdrawn of recognition order. A copy of the format to prefer the appeal is enclosed along with this order.
